GENERAL BUS RULES

Transportation is available to those pupils who live beyond a designated area from school. Rules and regulations governing transportation are established for the operation of the school buses. Transportation is considered a service provided by the school district and all students must abide by all rules and regulations. **Students who violate rules and regulations are subject to suspension of their bus riding privileges.** Below are the general bus rules, please retain them for your reference and sign and return the bottom portion to your school bus driver.

BUS RULES AND REGULATIONS

1. **Students are required to follow the bus driver's instructions at all times.**
2. **Students must be prompt at the bus stop.** When crossing the roadway to meet or leave the bus , students shall wait for bus drivers signal before crossing in front of bus and cross '10' feet in front of bus.
3. Students are to be seated, **facing forward both feet on or near the floor** not turned sideways or in isle or turned around facing back of bus. Students shall not open or close windows without permission from driver.
4. There will be **No Tolerance** for any behavior which jeopardized the safety of passengers or driver, i.e. **Drugs, Alcohol, Exiting rear door, Inflecting Bodily Harm, as well as Vandalism and Littering.**
5. **Respect** the driver and other students on the bus.
6. Students may talk quietly while on the bus. Students must be quiet at railroad crossings. **Foul Language and or Obscene Gestures will not be TOLERATED.**
7. Students must remain seated until the bus has come to a complete stop and air brakes are engaged.
8. **Students shall not consume FOOD OR DRINK while riding the bus. Other than BOTTLED WATER that can be closed without spillage.**
9. Aisles of the bus must be clear at all times.
10. **There will be no GUM OR CANDY allowed on the bus.**
11. **Friend ridership shall only be allowed with written consent from both parents of students.**
